3. Section 21 Declaration

Section 21 of the Firearms Act reads to the effect that: -

It is an offence for someone who is prohibited by Section 21 to have a Firearm or Ammunition in their possession at any time. Section 21 applies to anyone who has been sentenced to Imprisonment or to Youth Custody or to Detention in a Young Offenders Institution for three months or more. The period for which they are prohibited depends upon their length of service; if the sentence was longer than three years, the prohibition is for life. If the sentence was for three months or more, but less than three years, the prohibition lasts for five years from the date of their release. A person sentenced to 3 months imprisonment or more where the sentence is suspended is prohibited for a period of five years beginning with the second day after which the sentence is passed. It is an offence for a person to transfer, let or hire, give or lend a Firearm or Ammunition to someone whom he knows, or has reasonable grounds for believing to be prohibited under Section 21.
